

- First review of Reliability Settings since NEM establishment
- Major Review:
 - Submissions
 - Consultation
 - Analysis
 - Stakeholder Engagement

NEM Reliability Settings



Process

- Issues Paper (May 2006)
- Forum and submissions (July 2006)
- Interim report (April 2007)
- Submissions (May 2007)
- MCE Advice (July 2007)
- Second interim report (August 2007)
- Forum and submissions (September 2007)
- Final Report (November 2007)

Key Areas – Forward Program

- Exposure draft converted to Rule change proposal
- Final Report
 - Publish Reliability Standard
 - Recommendations and other Potential Rule changes
 - Areas to address:
 - Voll, CPT, Market Floor Price
 - Potential Additional Measures

Consultation

- Stakeholder Forum (13 September 2007)
- Submissions (28 September 2007)
- Panel Analysis and Deliberations (Report in November)

Reliability Standard

- Confirm the reliability standard:
 - Form (USE) ten years backwards
 - Level (0.002%)
 - Targeted annually NEM and regions
 - Scope:
 - generation and bulk supply
 - industrial action, "acts of God" exclusion
- Formal standard published with Final Report

Other Matters (1)

- NEMMCO's Reliability Directions Power:
 - Power in clause 4.8.9 to issues reliability directions extended beyond 30 June 2008, without a sunset.
- Require NEMMCO to report on accuracy of the load forecasts in the SOO
- NEMMCO to continue to calculate minimum reserve levels

Other Matters (2)

- Replace the annual VoLL review with a holistic review of all reliability settings every three years
- Recommend the AEMC reviews the Administered Price Cap arrangements
- Two major proposals in exposure draft:
 - Information (EAAP)
 - Safety Net (RERM)

Energy Adequacy Assessment Projection (EAAP) – 1

- Important additional information to allow for market responses – energy constraints vs. capacity constraints
- EAAP looks at impact of generator input constraints (e.g. drought):
 - updated quarterly by NEMMCO (against forward-view monthly USE)
 - outlook extends two years
 - aggregated data

EAAP - 2

- Generator energy models (GEMs):
 - provided to NEMMCO by the Generator
 - suitable for EAAP, agreed with NEMMCO
 - model parameters updated quarterly
 - GEM data confidentiality maintained
- Scenarios and Guidelines for the EAAP (Panel) and the GEM Guidelines (NEMMCO)

Reliability Emergency Reserve Mechanism (RERM) – 1

- Although the reserve trader is a distortion, on balance, a form of reliability safety net should be maintained for a defined period.
- The Panel acknowledges the wide-range of views held by stakeholders.
- Approach: redesign reserve trader with a four year sunset period.

RERM - 2

- Allows NEMMCO to contract for reserves (and non-scheduled reserves) up to 9 months ahead of projected shortfall
- Increases the flexibility for the tendering and contracting process
- Proposes tighter provisions to reduce double dipping
- Operates regionally and costs are recovered regionally

RERM - 3

- The Panel is looking at two possible funding arrangements:
 - recovering costs as they occur (exposure draft)
 - using an administered fund to spread costs over several years (canvassed in report)
