- (d) the National Gas (Queensland) Act 2008 of Queensland;
- (e) the National Gas (Tasmania) Act 2008 of Tasmania;
- (f) the National Gas (Victoria) Act 2008 of Victoria; and
- (g) the National Gas (Northern Territory) Act 2008 of Northern Territory;
- (h) the Australian Energy Market Act 2004 of the Commonwealth,

# National Gas Amendment (Publication of the GSOO and gas VAPR) Rule 2014 No. 1

#### 1 Title of Rule

This Rule is the *National Gas Amendment (Publication of the GSOO and gas VAPR) Rule 2014 No. 1.* 

#### 2 Commencement

This Rule commences operation on 1 April 2014.

#### 3 Amendment of the National Gas Rules

The National Gas Rules are amended as set out in Schedule 1.

#### Schedule 1 Amendments of the National Gas Rules

(Clause 3)

# [1] Rule 135KB Contents of gas statement of opportunities

In subrule 135KB(1), omit "on 1 January of the first calendar year to follow its publication" and substitute "on 1 January in the year of its publication".

## [2] Rule 135KC Revision of gas statement of opportunities

Omit the text of rule 135KC and substitute:

The gas statement of opportunities must be revised and re-published by 31 March each year.

# [3] Rule 135KD Publication of supplement to gas statement of opportunities

In rule 135KD, omit ", before the last quarter of a calendar year,".

#### [4] Rule 200 Definitions

In rule 200, omit the following definition:

**annual planning review** means the planning review to be provided by AEMO under rule 323.

## [5] Rule 200 Definitions

In rule 200, insert the following definition in alphabetical order:

**planning review** means the planning review to be provided by AEMO under rule 323.

## [6] Rule 323 Annual Planning reviews

Omit subrules 323(1) and 323(2) and substitute:

- (1) By no later than 31 March 2015 and by 31 March in every second year thereafter, AEMO must prepare and publish a planning review in accordance with this rule.
- (2) Each planning review must contain annual forecasts by system withdrawal zone of the matters set out in subrule (3) for each year of the 5 years, and (where practicable) for each month of the 12 months, commencing from 1 January in the year in which the planning review is provided to Registered participants.

## [7] Rule 323 Annual Planning reviews

In subrule 323(3) and in the heading for rule 323, omit "Annual".

## [8] Rule 323 Annual Planning reviews

In subrules 323(4), 323(4)(b) and 323(5), omit the word "annual" whenever it appears.

## [9] Rule 341 Notice of threat to system security

In subrule 341(1)(a), omit "annual".
