- (d) the Electricity National Scheme (Queensland) Act 1997 of Queensland;
- (e) the Electricity National Scheme (Tasmania) Act 1999 of Tasmania;
- (f) the National Electricity (Victoria) Act 2005 of Victoria; and
- (g) the Australian Energy Market Act 2004 of the Commonwealth.

National Electricity Amendment (Demand Management) Rule 2009 No. 11

1. Title of Rule

This Rule is the *National Electricity Amendment (Demand Management) Rule 2009 No. 11.*

2. Commencement

This Rule commences operation on 1 July 2009.

3. Amendment of the National Electricity Rules

The National Electricity Rules are amended as set out in Schedule 1.

Schedule 1 Amendment of National Electricity Rules

(Clause 3)

[1] Clause 5.6.2A Annual Planning Report

Omit clause 5.6.2A(b)(3) and substitute:

- (3) a forecast of *constraints* and inability to meet the *network* performance requirements set out in schedule 5.1 or relevant legislation or regulations of a *participating jurisdiction* over 1, 3 and 5 years;
- (3a) in respect of information required by subparagraph (3), where an estimated reduction in forecast *load* would defer a forecast *constraint* for a period of 12 months, include:
 - (i) the year and months in which a *constraint* is forecast to occur;
 - (ii) the relevant *connection points* at which the estimated reduction in forecast *load* may occur;
 - (iii) the estimated reduction in forecast *load* in MW needed; and
 - (iv) a statement of whether the *Transmission Network Service Provider* plans to issue a request for proposals for *augmentation* or a non-network alternative identified by the annual planning review conducted under clause 5.6.2(b) and if so, the expected date the request will be issued;

[2] Clause 6A.5.4 Building Blocks approach

In clause 6A.5.4(b)(6), after "clause 6A.6.6(c)", insert ", clause 6A.6.6(c1)".

[3] Clause 6A.6.5 Efficiency benefit sharing scheme

In clause 6A.6.5(a), after "clause 6A.6.6(c)", insert ", clause 6A.6.6(c1)".

[4] Clause 6A.6.6 Forecast operating expenditure

After clause 6A.6.6(c), insert

- (c1) If:
 - (1) a *Transmission Network Service Provider* made *network support* payments in accordance with a relevant agreement for *network* support services in the previous *regulatory control period*; and
 - (2) the *Transmission Network Service Provider* must continue to make *network support payments* to fulfil obligations under the relevant agreement for *network* support services in the relevant *regulatory control period*,

the AER must accept the forecast of required operating expenditure of the *Transmission Network Service Provider* included in a *Revenue Proposal* in relation to the remainder of costs required to meet obligations under the relevant agreement for *network* support services in the relevant *regulatory control period*.

[5] Clause 6A.6.6 Forecast operating expenditure

In clause 6A.6.6(e)(9), omit "and" where lastly occurring.

[6] Clause 6A.6.6 Forecast operating expenditure

In clause 6A.6.6(e)(10), omit "." and substitute:

; and

(11) the extent to which the *Transmission Network Service Provider* has considered and made provision for efficient and prudent non-network alternatives.

[7] Clause 6A.6.7 Forecast capital expenditure

In clause 6A.6.7(e)(9), omit "and" where lastly occurring.

[8] Clause 6A.6.7 Forecast capital expenditure

In clause 6A.6.7(e)(10), omit "." and substitute:

; and

(11) the extent to which the *Transmission Network Service Provider* has considered and made provision for efficient and prudent non-network alternatives.

[9] Clause 6A.14.1 Contents of decisions

In clause 6A.14.1(3)(i), after "clause 6A.6.6(c)", insert "or clause 6A.6.6(c1)".

[10] Clause S6A.1.1 Information and matters relating to capital expenditure

In clause S6A.1.1(6), omit "and" where lastly occurring.

[11] Clause S6A.1.1 Information and matters relating to capital expenditure

In clause S6A.1.1(7), omit "." and substitute:

; and

(8) any non-network alternatives considered by the *Transmission Network Service Provider*.

[12] Clause S6A.1.2 Information and matters relating to operating expenditure

In clause S6A.1.2(7), omit "and" where lastly occurring.

[13] Clause S6A.1.2 Information and matters relating to operating expenditure

In clause S6A.1.2(8), omit "." and substitute:

; and

(9) any non-network alternatives considered by the *Transmission Network Service Provider*.
